2020 State Legislative Report



Introduction

The 2020 legislative session was one for the history books. Most state legislatures adjourned abruptly as the COVID-19 crisis spread in the spring, and many held special legislative sessions during the summer and fall to wrap up unfinished business and address substantial revenue shortfalls stemming from the pandemic.

As states implemented restrictions to curb the spread of COVID-19, governors, state health departments, licensure boards, and commercial, federal, and nonfederal insurers issued emergency rules and regulations that expanded the ability of physical therapists and physical therapist assistants to provide therapy services via telehealth. Additionally, emergency rules were issued both by the Centers for Medicare & Medicaid Services and by many states to provide for payment of physical therapy and other health care services delivered via telehealth by Medicare, state Medicaid programs, and commercial insurers.

As a result of COVID-19-related shutdowns, many bills and final regulations planned for the 2020 session were put on hold. However, state chapters also scored valuable legislative wins on direct access, fair copays, telehealth, the Physical Therapy Compact, practice act updates, and more.

2020 Legislative Highlights

Athletic Trainers

Bills to license athletic trainers or expand athletic trainer scope of practice were introduced in a number of states, including Alabama, Arizona, California, Illinois, Kentucky, Maryland, Minnesota, Missouri, and Ohio.

Arizona's bill, which would have expanded the athletic trainer scope of practice to include dry needling, passed the Senate but languished in a House committee.

Efforts in California to provide for state licensure of athletic trainers and establish the California Board of Athletic Training ultimately languished in a Senate committee.

In Alabama, Illinois, Minnesota, and Missouri, bills aimed at eliminating the words "athlete" from the athletic trainer practice act, which would allow athletic trainers to treat virtually anyone whether they are engaged in athletics or not, were introduced. Our state chapters successfully opposed those bills.

In Kentucky, however, athletic trainers were successful in expanding their scope of practice, and now the medical board is in the process of developing regulations, as directed by SB 125. Both APTA and the Kentucky Chapter continue to have concerns over proposed credentialing standards, oversight, and scope of practice that appear far more expansive and less regulated than promised during the debate over the bill's passage.

APTA Maryland was successful in preserving language that limits the definition of "athlete" and "athletic training" in HB 576. The bill passed the House of Delegates unanimously with amended language offered by APTA Maryland, but the bill died upon adjournment without Senate action.

Direct Access

Legislation to expand patients' direct access to physical therapist services was introduced in Alabama, Minnesota, Missouri, and Tennessee. While the bills in Alabama, Minnesota, and Missouri did not pass, Tennessee achieved more liberal direct access provisions as part of a broader update of their PT Practice Act. SB 1960 was signed into law on July 15 by Republican Gov. Bill Lee.



Dry Needling

Bills that would allow PTs to perform dry needling were introduced in Florida, Hawaii, Idaho, and New Jersey. Republican Florida Gov. Rick Scott signed SB 792 into law on June 29, capping off a years-long campaign by APTA Florida to update their practice act to reflect modern standards of practice, including the ability of PTs to perform dry needling. The Florida Board of Physical Therapy is developing the dry needling regulations required by SB 792, and it is expected that the regulations will be promulgated in December.

In Idaho, HB 339, which permits PTs to perform dry needling, was passed unanimously by the state legislature and was signed into law by Republican Gov. Brad Little on March 10. The statute became effective July 1.

Unfortunately, efforts to permit dry needling by PTs in Hawaii failed after acupuncturists raised objections in committee about physical therapists infringing on the acupuncture scope of practice, despite dry needling also being part of the PT scope of practice. In New Jersey, efforts to allow PTs to perform dry needling failed in committee votes.

Fair Copays

Legislation that would prohibit insurers from charging PT copays greater than those for a visit to a primary care physician was introduced in Georgia, New York, Ohio, Rhode Island, and Vermont. Fair copay laws reduce cost barriers for patients and make physical therapy services more accessible.

Georgia's legislation, SB 28, was signed by Republican Gov. Brian Kemp on July 16, and APTA Georgia is now working with the Office of the Insurance Commissioner to develop enforcement regulations for the new fair copay statute.

Fair copay bills in New York, Ohio, Rhode Island, and Vermont were unsuccessful this year.

PT Compact

Bills that would allow states to join the Physical Therapy Compact were introduced in several states in 2020, and other bills that were introduced in 2019 were carried over to 2020. The District of Columbia, Pennsylvania, South Dakota, and Wisconsin passed compact legislation, bringing the number of states in the compact to 30. Several states are expected to introduce compact legislation during the 2021 legislative session.

Telehealth

The COVID-19 pandemic has led to a rapid expansion in the ability of PTs, PTAs, and myriad other health care providers to furnish patient care via telehealth. In response to the national shutdown in March, many states issued emergency rules permitting providers to deliver care via telehealth and requiring Medicaid and commercial insurer payment for services delivered via telehealth. Additionally, in April, Medicare announced rules permitting PTs to treat Medicare patients via telehealth.

While APTA continues to advocate to make the Medicare telehealth rules permanent, some state legislatures acted in special sessions to codify executive orders expanding the ability of providers to deliver care via telehealth and mandating payment parity for those services.

In Colorado, Connecticut, and New Hampshire, legislators passed legislation codifying executive orders allowing PTs and other health care providers to furnish service via telehealth, as well as mandating payment parity for telehealth services. However, due to the large presence of the insurance industry in Connecticut, the payment parity rule is set to sunset on March 15, 2021. Making payment parity permanent will be a top priority for APTA Connecticut during the 2021 session.



Additionally, many other states have expressed interest in codifying the ability of PTs to provide treatment via telehealth during their 2021 legislative, as the evidence has become clear that telehealth is an effective and efficient modality for delivering physical therapist services to patients.
